If NSDA points are not recorded for the student, the Head Coach or Assistant Coach should contact the President to determine the student's eligibility.

In order to compete at the Novice State Tournament, students must meet all of the following requirements:

- 1. The student must not have competed at any previous Novice State Tournament.
- 2. This is the first year of competition as a high school student (grades 9 through 12). If the student has competed in a total of two or fewer tournaments in previous high school years, that student would/shall still be considered a Novice competitor.

RECAP OF 2021 SPRING MEETING VIA MINUTES REVIEW

1 CONGRESS MANUAL

Gaba presented proposed changes

Hamm - packet of legislation - was it voted on it (pilot)?; separate that out in the vote - if pilot manual happens, need to get it out now, not later - ALSO, why NSDA materials

PILOT - Ben, Aly, Kate - doesn't vote on it, can be a test run for a year

Bo, Aly - larger committee and/or open to league for review

Aly - should parameters be in place for review of manual and proposed changes

Carol - send proposed changes in Word doc via email to league, invite feedback, then set up zoom call to discuss (open) the proposals - too much? too little? - then finalize language and send manual as a pilot manual for this season, see what works/didn't work, then break things down for ballot for Fall 2022, do point by point vote if needed

Aly - do this similar to conflict verbiage, coaches can comment, suggest edits, etc - committee of 3 can run the show if you will

Carol - NOT VOTING ON IT IN THE FALL - STILL A WORK IN PROGRESS - vote in 2022, will have meetings and open discussion for the league to comment, after final meetings between congress committee, pilot manual to be used for 2021-22 season, revisit this in Spring 2022 meeting, create separate voting items for Fall 2022.

3 REMOVE POLICY DEBATE JUDGE ROUND REQUIREMENT

Ryan - BYLAWS Rule 27K(1)

Paulette - don't we pay (per bylaws) - yes, 27K(5)

Derek, Nathan - uniquely difficult - either 12 rounds or hire? - only event with these provisions, need additional options for potential judges

Carol - maybe lower number of rounds?

Aly - can add in "previous year" - purpose for said rule, based on harassment of debaters, lack of knowledge of event, etc. - maybe create number of different options

- (a) 12 rounds in past three years
- (b) completed an FFL approved online judging course
- (c) hired out commitments (falls under A or B)
- (d) appeal to executive committee

4 ADD AFTER DINNER SPEAKING AND IMPROMPTU

Ryan - fun event, judges will love it, students love to use humor through persuasive/informative style, great for novices (better than declamation), add a public address event (was only OO before Info) - declamation only gives you delivery, ADS offers more and better skills - should be shorter (8 minutes max) - CROSS APPLY reasons for Impromptu

After-Dinner Speaking Event Description (from the National Forensics Association, a college league)

PURPOSE: A speech designed to entertain by advancing a relevant point through the use of humor.

DESCRIPTION: After-Dinner speeches are characterized by humorous content development, creativity, uniqueness, timeliness, clear organization, significance, credible sources, and vocal and nonverbal delivery choices that reflect the speech's purpose.

RULES:

- a. All speeches should be original, constructed and delivered by the student.
- b. Speeches should adhere to the NFA Code of Standards, Rules and Procedures.
- c. Plagiarism in any form is prohibited.
- d. Source citation should be specific, accurate and honest.

- e. Speeches should be delivered from memory.
- f. Visual aids are permitted. (FFL NO VISUAL AIDS)
- g. Maximum time limit of 8 minutes

Ben - not hard to implement, lost of rules from different states that can be incorporated, need another public address event, diversity from oratory and info

Kate - time limit concern - if reduced could trip up judges - was a midwest problem years ago - need clear justification for time limit difference

Derek - also time limit concern

Nathan - are visual aids needed? Only two tourneys in which to do. Equity issues with VAs, see that in Info as well. If a stepping stone, need to prohibit VAs to reduce that issue

Aly - adding another platform makes sense.

Ryan - VAs, hadn't even thought about it, but not opposed to this - can just write a speech, can attract individuals to the event - make it 9-12, not limited

Gaba - can be stepping stone for seniors for banquet speeches too :) plus, transfer to Toastmasters after graduating and in college

IMPROMPTU - follow NSDA rules

9 REDEFINE NOVICE STATE CRITERIA

Aly - intent is transition from MS to HS and confusion, lots of MS students competing at HS tourneys now - simplify it, create MS tourney to make distinction

Nathan - goal is to not have MS students go to VS or NS

Carol - this verbiage was only going to clarify what is a novice

Aly - intent of rule is to track incoming students, MS at HS level competition levels, what does this mean for novices? Goal is to simplify and allow only one NS tourney, max, period, per student

Bo - need to decide of we even want MS competing at NS - seems to be the real question here -

Aly - yes, correct - try to not have MS at NS and create a different opportunity instead

Ben - can we wait to see what MS tourney looks like? Maybe wait a year? Then make determination - need to have a MS tourney, separate MS out from NS

Carol - you only get one NS tourney, period - question of what constitutes a novice is the root of the problem, though - would need to change our verbiage for VS tourney, though, HOWEVER board of directors can say this year MS not competing sat regional qualifiers, but cannot vote on that rule change

Aly - make that verbiage something like, if qualify to VS as a novice, only year you can also attend NS. MSS, or other variation - if in MS, qual to VS, can attend all three, but in G9 can only attend VS - needs to change NS rule right now

Bo - need to know how many tourneys students competed at in MS when coming to HS - onus exists on HS coach level -

#1 - cannot have competed at any previous VS or NS tourney in a prior year

#3: first year compete at NS or VS constitutes novice year

Carol - exec board can implement a rule for one year

Aly - take hard-line stance - MSS will happen, advertise it as such - can't control if they sign up

STICK WITH ORIGINAL PROPOSED LANGUAGE - MS cannot compete at regional quals, though

It's on the fall ballot 15-3
